**Terms and Conditions** Customer acknowledges receipt and review of J.F. HILLEBRAND USA, INC. ("JFH") **Standard Terms and Conditions** ("Terms") governing all transactions between the Customer and JFH. These Terms may be found on the website, [www.hillebrand.com](http://www.hillebrand.com), and are available by written request at no charge. J.F. HILLEBRAND USA, INC, incorporated in the State of Delaware, U.S.A., is a Hillebrand Company. The parties agree that disputes regarding the Terms are to be interpreted under Federal and Delaware law and will be subject to jurisdiction and venue in the State of Delaware.

Rates provided in quotations are based on current freight tariffs, free choice of carrier, and valid until listed validity date. Accessorial charges such as bunker (BAF), inland, intermodal or low sulfur fuel are subject to monthly adjustment and no revised quotation will be sent. Wharfage, Pier Pass and terminal or shipping line collect fees are not included; these charges are collected directly by the ocean carrier or port terminal. **Delivery / Port-to-Door Service** Delivery is limited to legal cargo and axle weight only; Hillebrand is not responsible for overweight charges. Port to door service is subject to additional charges will vary by port and terminal; see rate quotation for details.

**Hillebrand Cargo Insurance** – Unless specified, prices/quotations exclude insurance. Multiple cargo insurance offerings are available. The signed insurance application must be in our possession prior to the shipping of the container to be eligible for coverage.

**Hillebrand Insulation Liner** - Through patented technology, Hillebrand has designed and manufactured a special insulation liner (VinLiner) for containers, pallets or cases. Take advantage of our VinLiner, available worldwide, to safeguard your cased products from thermal shocks, humidity infiltration, condensation, cross-contamination and odor. Specify Hillebrand Insulation liner (VinLiner) on your purchase order shipping instructions.

**VinRoute** is Hillebrand's exclusive internal database of shipping routes, temperature and humidity data. Wines and beer are highly perishable products, sensitive to changes in temperature and humidity and custom graphs allow you better decision-making control in selecting added protection either from Hillebrand Insulation (VinLiner) or an operating reefer.
